- b) **SCOPE OF TRAINING**: The selected candidates will have to undergo training either in Nuclear Fuel Complex, Hyderabad or in Zirconium Complex, Pazhayakayal, Tuticorin Dist. Tamilnadu in various aspects of relevant trades and for meeting stringent requirements of NFC/Zirconium Complex.
- c) The performance of the trainees will be watched during the course of the training period and in case the performance is found to be unsatisfactory, the traineeship is liable to be terminated. Note:

The prescribed educational qualifications are minimum and mere possession of the same does not entitle candidates to be called for written examination/interview. Where number of applications received in response to the advertisement is large and it will not be convenient or possible to hold written examination/interview for all of them, NFC reserves the right to restrict the number of candidates to a reasonable limit on the basis of marks and experience higher than the minimum prescribed in the advertisement.

GENERAL INSTRUCTIONS:

- **1.** Candidates will be required to attend in round-the-clock shift duties.
- The trainees after successful completion of training will be posted at Nuclear Fuel Complex, Hyderabad or in Zirconium Complex, Pazhayakayal, Tuticorin District, Tamilnadu or to any constituent units of the Department of Atomic Energy in India.
- **3.** The Candidates applying against the reserved vacancy for Physically Challenged persons should have at least a minimum of forty percent disability (moderate) certified by the appropriate medical authority.
- 4. Women candidates fulfilling the requirements for the above posts are encouraged to apply. Women employees are also eligible for specific benefits provided by the Govt. of India like Maternity benefits, child care leave, child adoption leave, special allowance to women with disability, creche facility etc., the details of which may be perused in the website of DoPT persmin.nic.in.

For Scientific Officers: The outstation candidates called for interview will be eligible for to and fro rail fare for IInd Class (**GENERAL CLASS**) or actual fare by the shortest route whichever is less, subject to the production of tickets/ticket numbers etc. However, Travelling Allowance is not admissible to those candidates who are already in Central/State Government services, Central/State Government Corporation, Public Undertakings, Local Government Institutions and Panchayats.

In addition to the normal pay, allowances viz. House Rent Allowance, Transport allowance etc. as admissible under the Rules, attractive incentives admissible in DAE will also be payable on completion of one year.

13. All the above advertised posts are governed by the Industrial Establishment. However, the posts under Medical Services/Fire Services and Stipendiary Trainees (on absorption as SA/B & T/B) are classified as Scientific & Technical category and their promotions to the next higher grades are governed by the merit promotion scheme existing in the Department of Atomic Energy.

Note: In case suitable candidates are not available in any of the above games/Sports, the Department reserves **the right not to consider other games/sports.**

SELECTION OF THE CANDIDATES (SPORTS)

The Applications will be scrutinized and suitable candidates will be shortlisted for Written Test and Physical Test in each discipline of **sports** as indicated by the applicant in his application form. Eligible candidates have to appear for a Written Test along with all other applicants. After qualifying in Written Test and Trade Test and Physical Test in respective **sports events**, the candidates have to appear for an interview. Success in the above tests/interview confers no right to appointment unless Department is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respects for appointment to the post.

HOW TO APPLY

FILL UP ALL COLUMNS OF THE APPLICATION FORM CAREFULLY.

1. The application in the prescribed format as given below, preferably typewritten on A4 size paper (30 cms X 21 cms) should be submitted and outer cover should be superscribed "Application for the post of _____ under Category No.____ " against "Advertisement No. NFC/01/2010". 2. Photograph:

A recent passport size photograph should be affixed on the right top corner of the application. One additional copy of passport size photograph should also be sent along with the application.

3. Copies of certificates:
