3. (*) **Your admission to the above said examination is provisional and strictly subject to submission of this Call Letter affixing latest photograph duly attested by a Gazetted Officer / Tehsildar or Deputy Tehsildar / Principal of Govt aided schools or colleges or institutions.**

4. You are advised to satisfy the eligibility with regard to requirements notified in the said advertisement, before appearing for examination. If any information or claim furnished by you is found to be incorrect at any stage of recruitment, your candidature will be cancelled. Decision of this Department is final in this regard.

5. At the time of commencing the examination, you will be supplied with OMR sheet for marking answers, you are required to adhere to the following guidelines:

- i) **Correct choice has to be darkened completely using Black / Blue Ball Point Pen.**
- ii) **Scratching, Overwriting, ticking / marking more than 01 (One) answer will be considered as void and will not fetch marks.**

Specimen copy of OMR sheet duly answered along with sample questions is enclosed for your guidance.

6. You are not permitted to carry Books, Reading material, Calculators, Mobile Phones, Pagers or any other electronic devices / goods into the Examination Hall.

7. You will not be allowed to enter the examination hall after half-an-hour of commencement of examination. You will be allowed to leave the examination hall only after One hour of commencement of examination (after collecting details of attendance etc.).

8. **A copy of this Call letter may be retained with you, as the original is required to be handed over to the Invigilator.**

9. No Travelling Allowance is admissible for your journey to appear for the above examination. However, if you belong to SC/ST category, coming from outstation, second class train fare by the shortest route from the place of residence or from the place of actual journey whichever is nearer to the place of written examination is admissible. You may submit the TA claim in the enclosed form, along with copy of community certificate, unemployment certificate from an MLA/MP/Gazetted Officer and tickets for the journey, provided the fare for the first 30 kms was borne by you.

10. No request for change of Venue / Date / Time fixed for examination schedule will be entertained and this Department is not liable for postal delay, if any.

11. Mere attending the above examination will not accrue any right to attend for Interview.

13. **The result of the Written Examination and dates of Interview will be displayed in NFC website – www.nfc.gov.in on or before 16.03.2013. Candidates qualified in the written examination will have to appear for Personal Interview tentatively from 18.03.2013 onwards. Exact date & time will be given in the website along with the result.**

14. **While appearing for Personal Interview, you should submit one set of documents related to**

- (i) **Educational Qualifications, Age, Community / Caste and originals for verification,**
- (ii) **NO OBJECTION CERTIFICATE from employer, in case you are employed under Central Government / State Government / Public Sector Undertaking / Autonomous body and**
- (iii) **Community Certificate as per the format prescribed by DoPT vide letter No.36033/28/94-Estt(Res) dated 02.07.1997 read with OM No.36011/3/2009/Estt(Res) dated 02.09.2009, in case you belong to Backward Caste & claiming to be OBC. The certificate of OBC including the creamy layer status should have been obtained not earlier than 06.08.2010.**

Without the above documents you will not be permitted to attend the Interview.

15. **No separate communication for attending interview will be sent and no claim in this regard will be entertained at a later date.**

16. **Canvassing in any form will be a disqualification.**
