under CHSS - reg.

Instances have come to the notice that many employees are visiting Zonal Hospitals and Departmental Medical Officers for medical facility relating to 3<sup>rd</sup> pregnancy and pressuring for treatment / medicines.

In this connection, an extract of Rule No. 10.6 of CHSS Rules on the subject matter is re-produced below :

"If the parents have more than two living children the beneficiary will not be eligible for ante-natal, post-natal treatment or confinement benefits under the Scheme, except in a medical emergency to be certified by the Staff Gynecologist."

Hence, all the CHSS beneficiaries are requested to make note of the above rule position and desist from such practice either at Departmental Health Centres or empanelled Hospitals. If any beneficiary still attempt to avail such medical facility, the concerned prime beneficiary would cease to become a CHSS beneficiary besides becoming liable for other action.
