**C I R C U L A R**

Consequent on introduction of CHSS scheme w.e.f 01.04.2003 in NFC for availing CHSS facilities, various circulars have been issued regarding the procedure to be followed while visiting Zonal Hospitals/ Super Speciality Hospitals/ AMAs / CMS / MO of OHC / CHC and also for drawl of medicines from the above hospitals / M/s. Sri Lakshmi Pharmacy Medical Hall at DAE colony. However, it is noticed that some employees are not adhering to the instructions issued from time to time in this regard. The following unusual activities have been observed which are required be avoided.

- 1) CHSS beneficiaries are approaching the Doctors at OHC/CHC/AMAs/Super Speciality Hospitals/Zonal Hospitals to issue medicines for more than one month at a time to themselves and their family members.
- 2) Some of the CHSS beneficiaries are using proxy CHSS cards of the beneficiaries who are transferred from NFC to avail medical facility.
- 3) Pages in CHSS health pass books are serially numbered . However, it is observed that some of the beneficiaries are removing / tearing the pages or adding additional pages to the health pass book, to hide the previous treatment details.
- 4) CHSS beneficiaries are approaching the Doctors of OHC/CHC to write prescription of inadmissible medicines to draw from M/s. Sri Lakshmi Medical Hall (which are not issued by the Super Speciality Hospitals / Zonal Panel Hospitals as per the agreement by NFC made with them).
- 5) Some beneficiaries are pressurizing the doctors to treat their relatives / friends, who are not members of CHSS.
- 6) Complaints have been received from the Doctors of OHC/ CHC/ AMAs/ Super Speciality Hospitals / Zonal Hospitals that CHSS beneficiaries are not maintaining proper decorum while visiting them and are sometimes unnecessary shouting in a high pitched tone or creating nuisance while visiting the hospitals.

7) CHSS beneficiaries are making duplicate cards ( by color Xeroxing the original CHSS card and getting them laminated).

8) Employees are approaching M/s.Sri Lakshmi medical hall for drawing medicines as recommended by AMAs though there is a provision that such medicines are to be purchased and submit the claim for reimbursement.

In view of the above observations, all employees and beneficiaries are requested to extend their co-operation. They may also note that irregularity if any noticed in their conduct shall entail them liable for action deemed fit besides cancellation of CHSS facility for themselves and their family members.
