- (3) Original certificates of SSC, Shorthand & Typewriting speed and other qualifications, along with attested copies of the same.
- (4) SC/ST candidates are required to produce original Caste Certificate along with attested copy of the same.
- (5) OBC candidates are required to submit original Caste Certificate in the prescribed format including creamy layer status obtained **on or after 12.04.2014** along with an attested copy of the same.
