Brief Description: Various types of Used/Condemned Vehicles such as Tata Trucks, Tata Sumo/M&M Jeeps, Fire Tender, Motor Cycles (Hero Honda Make) etc.

Brief Description: Various Unserviceable Machineries/Equipments/Furniture & Fixtures, General and E-Waste Items.

- b) Tender set containing the details of EMD, description of items, quantity and other terms and conditions attached therein can be had from the **Assistant Accounts Officer (Sales), NFC, Hyderabad, Tel.No.040-27184341 between 10:00 hrs and 15:00 hrs** on all working days from **24.10.2018 to 06.11.2018.**
- c) **Tenderers quoting/approaching for purchase of tender document have to submit copy of PAN Card and GST Registration copy along with Demand Draft to Assistant Accounts Officer (Sales) for issue of Tender document, in the name as mentioned on PAN Card/ GST Registration, to avoid future I.T. and GST complications.**
- d) **Tenderers quoting for the E-Waste items must be the actual users / re-cyclers/ dealers and should have registered with Ministry of Environment & Forest or authorized by State or Central Pollution Control Boards / Pollution Control Committees in Union Territories. Copy of valid registration / authorizations issued by the said authorities must be accompanied with the tender, failing which such tenders will be summarily rejected.**
- e) **Demand Draft of Rs.50/- to be drawn in favour of Pay & Accounts Officer, NFC, Hyderabad payable at SBI, NFC Branch (Code : 9071) for purchase of each tender set (Non-refundable).**
- f) Request for tender documents by post must reach the above mentioned address 08 days prior to the last date of sale of tender document.
- g) **Detailed Description of items with quantities & EMD are given in the Tender Document.**
- h) In case the last date for sale of Tender forms/due date happened to be declared as holidays, the date will concurrently be extended to the next working day.
