On behalf of President of India, sealed item rate tenders are here by invited for the work described below from contractors those who have successfully executed work of this type in the past.

1. Name of the work : Removal of wild vegetation in transformer yards.
2. Estimated cost : Rs.3,88,000/ -
3. E.M.D. : Rs.7,780/-
4. Security Deposit : 2.5 % of work order value.
5. Performance guarantee : 5% of work order value.
6. Time limit for completion of work : Twelve Months
7. Guarantee period : NA
8. Sale of tender : 13.07.2017 to 27.07.2017
9. Last date for submitting : 04.08.2017, 14.00 Hrs.

Tender documents and schedules can be had from Office of Sr. Superintending Engineer, Power Distribution, NFC, Hyderabad in office hours after submitting the copies of documents in support of the competency, latest income-tax clearance and on submission of documents of experience with a Crossed Demand Draft for Rs.500/- in the name of **Pay & Accounts Officer**, NFC towards cost of tender document. The duly filled tender document and D.D. towards EMD shall be submitted in separate covers and same are to be submitted in an envelope duly sealed with superscription viz., name of the work, tender no., etc., the department however shall not be

responsible for delay or loss of tender papers in postal transit or otherwise. Tenders shall be dropped in tender box (kept in the office of Sr. Superintending Engineer(PD), 2nd Floor, Power Distribution(PD) building, Nuclear Fuel Complex(NFC)-Hyderabad) up to 14.00 hrs on 04.08.2017 and will be opened at 14.30 hrs. on same day (If it happens to be holiday, then the next working day) in the presence of tenderers or their authorized representatives whoever choose to be present. The Sr. Superintending Engineer (Power Distribution) reserves the right to accept or reject any or all the tenders either partly or fully without requiring / assigning any reasons thereof. Late/delayed/conditional tenders shall not be accepted under any circumstances.

NOTICE INVITING LIMITED TENDER
(Tender Notice No. NFC/PD/04/ 2017)

1. Item rate limited tenders are invited on behalf of the President of India from approved and eligible contractors of DAE and those of appropriate list of CPWD, Department of Telecommunications, M.E.S., Railways and A.P. State P.W.D., for the work of

“Removal of wild vegetation in transformer yards”

- 1.1 The work is estimated to cost **Rs. 3,88,800/ - (Rupees Three Lakh Eighty Eight Thousand Eight hundred only)**. This estimate, however, is given merely as a rough guide.
- 1.2 Tender documents will be issued to eligible contractors provided they produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below: -
- 1.3 Criteria of eligibility for issue of tender documents

For the purpose of this clause eligibility for ‘similar work’ means, " removal of wild vegetation in substations / maintenance of gardens/ Housekeeping of substation premises "

- 1.4 Contractor shall submit solvency certificate from any schedule bank of value not less than 40% of estimated cost not older than last financial year unless otherwise indicated in the NIT .
- 1.5 Contractor shall submit audited balance sheets indicating value of works carried out / in progress, loss / profit for last 5 years.
- 1.6 Contractor shall submit technical establishment and equipment / machinery.
Contractor shall submit the proof of certificates duly attested by the gazetted officer (central / state government)
2. Agreement shall be drawn by the department with the successful tenderer on prescribed Form enclosed. Tenderer shall quote his rates as per various terms and conditions of the said form, which will form part of the agreement.

3. The time allowed for carrying out the work will be **Twelve Months** to be reckoned from the 15th day after the date of issue of work order to commence the work or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
4. The site for the work is available.
5. **Tender documents consisting of specifications, schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be purchased from the office of the Sr. Superintending Engineer, Power Distribution office, NFC, Hyderabad, between hours of 10.00 A.M. & 04.00 P.M. everyday except on Sundays and Public Holidays or holidays declared by NFC. The tender documents will be issued from this office, during the hours specified above from 13.07.2017 to 27.07.2017 on payment of Rs. 500/- (non-refundable) by way of Bankers cheque/Pay Order/ Demand Draft drawn in favour of PAY & ACCOUNTS OFFICER, NFC.**
6. Contractors must produce their IT PAN No, Copy of PAN card may be submitted. On award of work, IT @2% as applicable will be recovered from bills.
7. Tenders which should always be placed in sealed envelope, with the name of work and due date written on the envelopes, shall be dropped in tender box (kept in the office of Sr. Superintending Engineer(PD),2nd Floor, Power Distribution Building, Nuclear Fuel Complex-Hyderabad) up to **14.00 hrs. on 04.08.2017** and will be opened by Sr. Superintending. Engineer (PD) or his authorized representative on the same day at **14.30 hrs.**
8. The tender shall be accompanied by earnest money of **Rs. 7,780/- (Rupees Seven Thousand Seven Hundred Eighty only)** in the form of Demand Draft /Pay Orders/ Banker's Cheque or Deposit at Call receipt of a Scheduled Bank issued in favour of **PAY & ACCOUNTS OFFICER**, NFC Hyderabad. Name & A/C No. of contractor may be written at the back side of DD submitted for EMD and the DD submitted should be valid for 3 months.
- 8.1 The tender and the earnest money shall be placed in separate sealed envelopes each envelope marked with "**Tender**" and "**Earnest Money**" respectively. Both the envelopes shall be submitted together in another sealed envelope written with name of work and Tender Notice number and addressed to Sr. Superintending Engineer , Power Distribution, Nuclear Fuel Complex, Hyderabad. The envelopes marked "Tender" of only those tenders shall be opened, whose earnest money placed in the other envelope is found to be in order.
9. The description of the work is as follows :

" Removal of wild vegetation in transformer yards "

Detailed technical specifications are enclosed as Schedule of quantities

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the form and nature of the site, the means of access to the site. The accommodation they may require and in general shall themselves obtain all necessary

information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

10. The competent authority on behalf of President of India does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tenders received without the assignment of a reason. All tenders in which any of the prescribed conditions are not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
11. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
12. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rates quoted.
13. The contractor shall not be permitted to tender for works in NFC (responsible for award and execution of contracts) in which his near relative is posted as Assistant Accounts Officer or as an officer in any capacity between the grades of Chief Engineer and Assistant Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in NFC or in the DAE. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
14. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of two years after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractors service.
15. The tender for the works shall remain open for acceptance for a period of 120 **(One hundred twenty days)** days from the date of opening of tenders. If any tenderer withdraws his tender before the said period or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid.

16. This Notice Inviting Limited Tender shall form a part of the contract document. The successful tenderer/contractor, on acceptance of his tender by the Accepting Authority, shall, within 15 days from the stipulated date of start of the work sign the contract consisting of:-

The notice inviting tender, all the documents including Tender of contract, General rules and directions, clauses of contract, proforma of schedules, safety code, Model rules, contractors labour regulations, proforma of registers, special instructions to tenderers, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.

17. Taxes as applicable will be recovered from the bills.
18. Performance guarantee @5% work order value shall be submitted within 15 days from the date of issue of letter of acceptance in the form of FDR/DD/BG. Extension of time for submission of PG at the request of contractor shall be charged @0.1%/day of PG amount.
19. On non-submission of PG within the prescribed / extended time, the earnest money will be forfeited.
20. Security Deposit @2.5% of work order value will be recovered from bills. Same will be released after three months from the date of completion of work or after the payment of final bill whichever is later.
21. If the contractor abandons/ breaches the contract after commencement of work, then the performance guarantee submitted by you and the security deposit recovered for the work shall be forfeited.
22. Police Verification certificate, Medical Fitness certificate and ESI & EPF certificates should be produced for the contract labour engaged for the work.
23. Minimum wages, as circulated by RLC(C), Hyderabad should be paid to the contract labours.
24. The contract labours engaged for the should wear the uniform which shall be distinct from NFC uniform.
25. **The contractor shall submit the valid registration certificates of ESI & EPF for issuing of tender documents.**
