ORDER

WHEREAS a Work Order No. NFC/GM(F)/NUFAP/WO-1/2013 dated 26.03.2014 was issued to M/s VLR Associates for the job of Material Handling and Zr. Scrap Cleaning at NUFAP;

AND WHEREAS M/s VLR Associates was required to obtain Police Verification Certificate in respect of the labourers engaged by them as per the terms of the Work Order dated 26.03.2015 based on which entry passes were to be issued to their workers to enter NFC premises for performing the said job;

AND WHEREAS M/s VLR Associates submitted application for renewal of entry passes for the workers engaged by them in to NFC premises on 21.4.2015 which was approved by Competent Authority;

AND WHEREAS after approval of the Competent Authority for entry of their workers in to NFC premises M/s VLR Associates was found to have tampered with the document and submitted to Central Industrial Security Force for issue of Gate Pass in order to get entry of unauthorized person in NFC Premises;

AND WHEREAS CISF authorities had noticed the above said tampering of records and intimated the same to the authorities concerned vide their letter No. CISF/NG/PASS SECTION/85 dated 22.08.2015;



AND WHEREAS a Show-cause notice dated 09.09.2015 was issued to M/s VLR Associates seeking explanation as to why their firm should not be blacklisted and the contracts awarded to them shall not be terminated for their above mentioned misdeed;

AND WHEREAS M/s VLR Associates submitted a representation dated 10.09.2015 stating that their Proprietor being uneducated and it was a mistake committed by their supervisor and their proprietor did not have any intention to cause harm to NFC and requested sympathetic view considering their poor financial background;

AND WHEREAS after going through the records of the case including the explanation submitted by M/s VLR Associates, the undersigned holds that M/s VLR Associates is vicariously liable for the act committed by their workers and that M/s VLR Associates have committed a serious act of manipulation thereby bringing unauthorized person inside Plant premises which is a security threat.

NOW THEREFORE, in exercise of powers vested in me vide COR No. 3/90 dated 11.02.2014, taking the threat perception into account and the act of misconduct on the part of the representative of M/s VLR Associates, I order that M/s VLR Associates shall be black listed for the period of one year and all the contract awarded to them shall be terminated with immediate effect.
