On behalf of the President of India, sealed tenders are invited from competent and well experienced vendors for the following work on works contract basis.

- 1) Name of Work** : Periodic cleaning of Tanks, Pipelines and Exhaust ducts at ZOP
- 2) Scope** : As per Annexure – I
- 3) Duration of work** : **ONE YEAR (310 days)** from the date of commencement of work
- 4) Estimated Cost** : **Rs. 7,82,874/-** (Rupees Seven lakhs eighty two thousand eight hundred seventy four only)
- 5) Earnest Money Deposit: Rs. 15,660/-** (Rupees fifteen thousand six hundred and sixty only) in the form of FDR/DD/BC drawn in favour of "Pay and Accounts Officer, NFC" payable at Hyderabad shall be submitted. Offers without EMD will be summarily rejected.

Name & Account number of contractor may be written at the backside of DD submitted towards EMD and the DD to be submitted shall be drawn after the date of release of NIT to ensure that it is valid for the entire offer period.

- 7) Last date for submission of tender** : **On** 24-04-2017 up to 14:00 hours
- 8) Date of opening the sealed tenders** : **On** 24-04-2017 at 15:00 hours
- 9) Cost of tender document** : **Rs. 500/-** (Demand draft or Banker's cheque payable at Hyderabad drawn in favour of "Pay and Accounts Officer, NFC")

Quotations are to be submitted strictly in the format enclosed. Tender & EMD shall be enclosed in two separate envelopes clearly indicating tender details & each marked as TENDER & EMD respectively. Both the envelopes shall be submitted together in another sealed envelope subscribing tender no. & description of work along with due date and time of submission on the outer cover.

Your offer shall be deposited in tender box kept for the purpose at Manager(ZOP) Office, Nuclear Fuel Complex, ECIL Post, Hyderabad-500062 by 24-04-2017 till 14:00 hours.

Tenders will be opened at Works Section, IIIrd floor, Aadhar Building, NFC. Late/delayed & tenders not accompanied by EMD shall not be considered.

Tender documents issued to contractors are non-transferable.

Terms and Conditions of NIT No: NFC/ZOP/03/PC/2017/06 dated : 11-04-2017

1. Tenders will be issued to eligible contractors from the office of Manager(ZOP), provided they produce the following documents:
 - a. Crossed DD/Pay order/Banker's Cheque in respect of tender cost (non-refundable) drawn in favour of Pay & Accounts Officer, NFC, Hyderabad
 - b. Copy of PAN card and registration certificate
 - c. ESI and EPF certificate for their employees, to whom the firm is supposed to engage for this work along with valid payment certificate.
 - d. List of works executed together with the certificate/testimonials from clients in support of the like nature and magnitude during the last five years.
 - e. Definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority of having satisfactorily completed similar works in production plants of magnitude specified below:
 - i) 03(Three) each of 40%
 - ii) 02 (Two) works of 60%
 - iii) 01 (One) work of 80% of the estimated cost
 - f. Audited balance sheet duly indicating the turn-over and tax paid for the last five years
 - g. Valid solvency certificate for 40% of the estimated value of the work, from any scheduled bank in support of financial standing.
2. The contractor will be completely responsible for the job. The contractor shall deploy sufficient manpower (skilled and semi-skilled) required for completion of the work (as mentioned in Annexure -I) in a period of one year. The contractor shall ensure to authorize a competent person to supervise the job who shall be fully responsible for carrying out the jobs safely. Supervisor deployed for the job shall be minimum diploma holder or equivalent. Authorization shall be furnished in writing. The contractor shall deploy only those qualified manpower who have prior experience in the works as brought out in the scope of work.
3. No child labour should be engaged.
4. The working personnel are to be engaged in I/ II/ General Shifts.
5. The workers engaged by the contractor should wear uniform which is distinct from NFC uniform. Safety shoes and other PPEs as required for the job are to be provided by the contractor for all the workers engaged by him and ensure their usage. The contractor has to ensure safe working practices and follow all safety rules and regulations stipulated by SED, NFC from time to time.
6. The Contractor must follow all Labour Laws such as Contractor (Regulation & Abolition Act), Payment of Wages Act, EPF & MP Act, ESI Act, Payment of Bonus Act, Employees Compensation Act, etc. NFC reserves the right to ask Contractor to furnish proofs/documentary evidence for following above laws. Clarification on statutory provisions if any may be sought from Welfare Officer, NFC, Hyderabad on 040-27183059 or wo@nfc.gov.in on any working day during office hours.
7. Wages are to be paid as per minimum wages act, notified by RLC(C) from time to time.
8. Earnest money deposit @ 2% of estimated cost put to tender shall be submitted along with tender in the form of FDR/Crossed DD in favour of "Pay & Accounts Officer, NFC" payable at Hyderabad. Offers without EMD will be summarily rejected.
9. Certificate from Officer-In-charge at NFC regarding payment of minimum wages to the contract labour is to be enclosed along with claim.

10. The contractor shall produce necessary police verification certificates from the local police station for the manpower being engaged for the purpose.
11. Valid Medical fitness certificate including certificate to work at height from at least an MBBS doctor for the workers engaged shall be submitted. The Contractor shall ensure that all his labours who are engaged in work are covered under ESI and EPF. Proof of the same shall be produced before start of work.
12. The quoted value shall be **exclusive of ESI, EPF, Service Tax & inclusive of any other mandatory duties and levies of the Government**. The same will be released against submission of documentary evidence towards payment of ESI, EPF & service tax to the concerned authorities.
13. The contractor shall provide the registration details of Income Tax, Sales Tax, ESI, EPF, Service Tax, etc. while collecting tender document and copies of the same shall be submitted along with tender document.
14. Performance Guarantee @5% of Work Order value must be submitted within 4 - 15 days from the date of issue of letter of acceptance in the form of fixed deposit receipts or DD or Bank Guarantee. In case a Bank Guarantee is furnished, it should be valid for 14 months from the date of issue of work order along with an additional claim period of SIX months. Extension of time for submission of Performance guarantee at the request of contractor shall be charged @0.10% per day of performance guarantee amount.
15. In case of non submission of performance guarantee within prescribed/ extended time, the earnest money deposit submitted will be forfeited.
16. Security Deposit @ 2.5% of the Work Order value shall be recovered from running account bills. The security deposit amount recovered shall be released after three months from the date of completion of entire work or after payment of final bill, whichever is later, without any interest.
17. Income tax @ 2% or as applicable at source shall be deducted from the payment made. Contractors should furnish their PAN number and bank details along with a xerox copy of the same duly countersigned by him to Accounts Officer, NFC. Non-submission or incorrect submission of PAN attracts IT @20% on the gross bill.
18. Payment for the work done by the contractor shall be made based on the work done by contractor which was accepted and measured by the Officer-in-Charge, duly approved by the competent authority. Payments shall be made on monthly basis.
19. Offers received will be evaluated based on the total cost quoted exclusive of EPF, ESI and Service Tax, etc.
20. The offer should be kept valid for a period of three months from the date of opening of tender.
21. Incomplete and conditional tenders shall be rejected. However unconditional rebates are acceptable. Contractor shall quote the rates both in words and figures.
22. In case there is variation between the rates in figures and words, the rate which corresponds to the amount worked out by the contractor shall be taken as correct.
23. When the amount of an item is not worked out by the contractor, or if it does not correspond with the rates written either in figures or in words, then the rate quoted by the contractor in words shall be taken as correct.

24. When the rate quoted by the contractor in figures and in words tallies, but the amount is not worked out correctly, the rate quoted by the contractor shall be taken as correct and not the amount.
25. The contractor shall sign each page of the tender document along with the schedule of quantities & rates.
26. In case the contractor fails to commence the work specified in the tender document within the prescribed time schedule, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit whole Performance Guarantee absolutely.
27. The contractor shall ensure that labour deployed for the contract would confine themselves to their respective places of work and not indulge in activities that would be harmful to NFC.
28. NFC reserves the right to accept or reject any quotation, either completely or partly, without giving any reasons.
29. If on acceptance of the tender, owing to circumstances, if the scope of the work remains altered, reduced or abandoned for any reason, NFC shall give a notice in writing to that effect to the contractor who shall act accordingly. Also, if the workmanship is not satisfactory, the contract shall be cancelled.

31. If the contractor fails to execute the work completely, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit whole Security Deposit and Performance Bank Guarantee absolutely.
32. If the L-1 bidder quoted much lower than the estimated cost, then a Bank guarantee for the differential cost may be obtained from the L-1 bidder as per CVC guide lines.

2. Daily removal, cleaning and fixing back of SS exhaust ducts, nozzles and other process pipe lines and opening of 14" & 16" flanges for removal of muck and fixing back.
3. Daily cleaning of LS strainer, connection and disconnection of pipe lines of pumps, valves and other minor works in the shifts.
