**MINUTES OF THE SCREENING COMMITTEE MEETING FOR
THE COMPASSIONATE APPOINTMENTS HELD ON 03.06.2025**

A meeting of the Screening Committee for Compassionate Appointments was held on 03.06.2025 at 14.30 Hrs. at NFC, Hyderabad – 500 062 to assess the suitability or otherwise of candidates considered for compassionate appointment.

2. Department of Atomic Energy vide OM No. 24/6/2014-SCS/6040 dated 06.05.2022 and DAE OM No. 24/7/2024-SCS/15488 dated 29.10.2024 have formulated Relative Merit Point on 100 point scale to be adopted uniformly in all the DAE Units in accordance with DoPT OM F No. 14014/1/2022-Estt.(D) dated 02.08.2022.

3. In this regard, the Screening Committee evaluated Nine (09) Applications for Compassionate Appointment received from the family members of the deceased employees of NFC in accordance with DAE vide OM No. 24/6/2014-SCS/6040 dated 06.05.2022 & DAE OM No. 24/7/2024-SCS/15488 dated 29.10.2024 had prescribed relative merit points on 100 points scale for screening applications for compassionate appointment.

4. On the lines of above instructions, the Screening Committee considered five review cases and four fresh cases based on financial condition of the family, assets and liabilities, presence of an earning member, size of the family, ages of the children, essential needs of the family etc. Accordingly, the Committee examined the following Nine (09) cases and made its recommendations:
